#### Warranty for Bariatric Surgery

In developing this warranty for bariatric surgery the Accountable Payment Model (APM) subgroup of the Dr. Robert Bree Collaborative relied most heavily on three similar initiatives creating a warranty for total knee replacement (TKR) and total hip replacement (THR), lumbar fusion, and coronary artery bypass surgery. It is our opinion that bariatric surgery, coronary artery bypass surgery, lumbar fusion, and total joint replacement shared sufficient similarities with respect to readmission to the hospital for avoidable complications that the model is transferrable.

The warranty for TKR and THR was based on a study of complications of these surgeries commissioned by the Centers for Medicare and Medicaid Services (CMS) and subsequently adopted by the High Value Healthcare Collaborative (HVHC), a group of 18 major medical systems from across the country founded by the Dartmouth Institute. The primary intent of the bariatric surgical warranty is to set a high priority on patient safety. It is also intended to balance financial gain for providers and institutions performing bariatric surgery with financial accountability for complications attributable to these procedures. In this warranty the intent is to distribute financial risk across professional and facility components in proportion to the revenue generated by the procedure.

This warranty, like the Bariatric Surgical Bundle, excludes revision to a previous bariatric surgery, pregnancy, intent to become pregnant within a year of surgery, active drug and/or alcohol abuse, active life-limiting illness that would preclude benefit from weight loss, cognitive, motivational, or emotional conditions that would preclude understanding and participating in the care plan, or other factors as determined by the multidisciplinary team

Complications for warranty are intended to meet the following criteria:

- Represent significant complications attributable to the bariatric surgical procedure.
- Are identifiable in administrative claims data
- Are fair to hospitals and physicians
- Are meaningful to patient outcomes
- 1. Surgical complications:
  - a. Mechanical complications related to non-healing of abdominal wound
  - b. Wound infection:
    - Incision and drainage
    - Revision
  - c. Surgical site bleeding requiring readmission for incision and drainage
  - d. Pulmonary embolism
- 2. Medical complications:
  - a. Acute myocardial infarction
  - b. Pneumonia
  - c. Sepsis/septicemia

#### Warranty period and other terms

1. Warranty period is complication-specific:
