#### **CHAIR REPORT AND APPROVAL OF MINUTES**

Dan Lessler, MD, MHA (Chair) and Ginny Weir, MPH, Bree Collaborative opened the meeting and those present introduced themselves. Ms. Weir discussed a timeline for a final draft for recommendations for this work group and the goal for the meeting to finalize focus areas at the next meeting. A motion was made to approve the minutes from the previous meeting.

*Motion*: Approve 3/14/2018 Minutes. *Outcome*: Passed with unanimous support

#### **FINALIZING FOCUS AREAS**

The group reviewed LGBTQ Health Care Recommendations and discussed:

- Adding more information to "Appropriate Next Steps" and referral resources for identified needs in screening
- Basis for choosing which types of questions to add to screening or social history
  - o Follow risk profiles for people in the LGBTQ community
- Adding a non-binary response in Social History Sexual Partners
- Removal of question of lifetime sexual partners
  - o People may not know
  - No medical benefit
- Distinguishing between insertive vs receptive sexual activity
  - Using terminology top, bottom, or versatile

**Action Item:** Michael Garrett, MS, CCM, CVE, NCP, Principal, Mercer to write additional language for definitions

Action Item: Scott Bertani, Lifelong AIDS Alliance to send colloquial names for HIV

- Specify which types of drugs being used in social history
- In next steps added HIV and STI testing according to WA state guidelines
- Reference HHS guidelines for HIV treatment
- Adding guidelines for asking about gender identity and orientation questions with adolescents and what age to start
  - o David Breland and Taraneh Shafii at Seattle Children's to be consulted
- Adding Seattle Children's to resource
- Including recommendations on "Systems of care" i.e. EHRs,

**Action Item:** Matt Golden, MD, Professor, Director, PHSKC, STD Control Program, University of Washington, to draft language about changes to systems of care

Inclusion of sexual activity that expose to bodily fluids that are not seminal or vaginal

Action Item: Scott Bertani to reach out to Center for Sex Positive Culture for possible language

- Inclusion of explicit language for non-judgmental, non-stigmatizing behavior on behalf of providers
- Added clinics, health systems, to stakeholder specific information that was previously hospitals
- Adding the requests that when providers encounter a person who is HIV positive not in treatment that they contact the Department of Health
- Quarterly HIV/STI testing and PrEP without copay
- Addressing inequity in coverage of infertility treatments that require opposite sex couples
- Addressing roadblocks to trans masculine top surgery

**Action Item:** Ginny Weir to send revised draft to group for feedback on language, organization etc.
