REVIEW PREVIOUS SHARED DECISION MAKING EFFORTS

Karen Merrikin, JD, Contract Program Director and Laura Pennington, Washington State Health Care Authority, discussed the background of shared decision making in Washington State and the *Literature Review for Shared Decision Making* including:

- HCA Thought Leader Group discussion and process
 - Though Leader Group Vision
 - o Goals were increased update of shared decision making
 - Use of the National Quality Partners Playbook
- Facilitators and barriers of using shared decision making

PRELIMINARY SCOPE OF WORK

Workgroup viewed Draft Charter and Roster along and discussed preliminary scope of work including:

- Removal of "reduce costs" from *Problem Statement*. There are questions as to the applicability of the original study from Group Health to cost savings generally.
- Changed statement in Aim from "across Washington State" to "across the country"
- Group discussed including policy requests that would mandate widespread adoption
- Changed bullet in *Purpose* from "enablers for practice transformation" to "enablers for shared decision making adoption and sustainable use."
- Additional members to add to roster
 - Regence representation
 - Diverse patient advocate(s)
 - o Providence St. Joseph representation
 - Tribal provider representation.
 - Ginny has emailed Urban Indian Health Institute.
- Group would like to see a presentation from shared decision making aid developers
- Identifying high impact areas where high quality decision aids are needed
- Premera has some patient decision aids on their website from Healthwise
- Language needs to be culturally appropriate and have easy to understand facts and numbers.
 - Needs to be applicable to rural areas as well.
