Implementation Spotlight

This past year we led a pilot group of 10 primary care clinics, facilitated a broader learning community supported by nine monthly webinars, and held two summits for indepth looks into integrating behavioral health into primary care and on moving our health care system to paying for value over volume.

While expectations for our pilot group had to be adjusted once clinic resources were redirected towards COVID response, the Bree is proud of what was accomplished. Work at the clinics included improving the warm handoff process from physical to behavioral health, creating strong reporting infrastructures to tack screening, implementing social determinants of health screening, and integrating the Prescription Monitoring Program (PMP) into electronic medical records. While this work was not directly related to COVID, continued work on behavioral health is especially important this year, in context of the increased mental and emotional stress that people are feeling as a result of isolation and a global pandemic.

Looking to 2021

We have four workgroups on our docket for 2021 as well as finishing our social determinants of health work. In January we will be holding meetings for cervical cancer screening, opioid use in older adults, telehealth, and rereviewing our total knee and total hip replacement. The full Bree Collaborative will continue to meet every other month.
