CHAIR REPORT, APPROVAL OF MINUTES

Hugh Straley opened the meeting.

Motion: Approve the July 28, 2021 Meeting Minutes

Outcome: Passed with unanimous support

FINAL ADOPTION: TELEHEALTH REPORT AND RECOMMENDATIONS

Shawn West, MD, Embright, workgroup chair outlined the members and process to develop the telehealth recommendations. Dr. West outlined clinical components of person-centered interactions, reinforcing continuity of care, measurement and follow-up especially around disparities of care, and defining appropriateness. Members discussed the decision to focus on physical health care services rather than behavioral health, evidence brought on by the move to virtual health due to the COVID-19 pandemic.

Motion: Adopt Telehealth Report and Recommendations.

Outcome: Passed with unanimous support.

DISSEMINATION FOR PUBLIC COMMENT: TOTAL KNEE AND TOTAL HIP REPLACEMENT

Bob Mecklenburg, MD, workgroup chair, presented on the third iteration of the bundle, thanking members, the process, and the evidence table development with 200 citations. Changes from the 2017 edition include within: personal care partner, social determinants of health (particularly transportation needs), infection control, surgical implants (particularly those that deviate from the average in failure or safety to the detriment of the patient), and same-day discharge (within 24 hours of surgery). Members discussed vaccine mandates and the impact on patient care, physicians disclosing their conflicts, use of anticoagulants, and whether patients must also be vaccinated against COVID-19.

Motion: Disseminate Total Knee and Total Hip Replacement Bundle for public comment.

Outcome: Passed with unanimous support.

DISCUSSION: NEW TOPICS

Ginny Weir, MPH, Foundation for Health Care Quality opened the discussion with acknowledging COVID-19 as the third leading cause of health after heart disease and cancer, thanking Karen Johnson for her time as a Bree member, and broke members and those who are members of the public into breakout rooms to discuss past topics, successes and false starts. In breakout groups those present discussed: purchasing and contracts like the bundles, interest in collaborative care, interoperability and defining what it means as CMIOs meet informally monthly, and an interest in both healthy weight management and Hep C. Members discussed wanting to have a standard mechanism to discuss and contract for equitable healthcare, that adverse childhood experiences are certainly impactful but difficult to know how to integrate into a contract. Members participated in a series of straw votes and discussed pros and cons of the topics.

Motion: To work on for 2022

- Infection control
- Hepatitis C
- Pediatric asthma
- Low back pain

Outcome: Passed by majority vote.
