drive the development of the tool in each organization.

Workplan Review Group

Thoughts on discussion with Kathy Mazor

- Thought there were parallels with the diagnostic workgroup
- Interesting that the We Want to Know campaign was difficult to implement and the most successful aspect was the use of a CAN to round to collect patient feedback.
- Impression that measurement was difficult. Maybe we just do something and see if it moves any of the current measures.

#### Discussion of current direction of project

- Discussed idea of shifting strategy to source processes and tools used at WA healthcare institutions to encourage <u>patients</u> to engage their healthcare team when risk/safety issues arise
  - Group will contact peers at WA institutions by phone survey to determine processes and tools used at their facilities
  - Steve can do scan outside WA
  - Steve to develop draft interview questionnaire for group to refine
    - Do you have a speak-up campaign?
    - What tools are they using in the campaign?
    - Do they call out "patient speaking up campaign in their patient safety plan?
    - Or who does your speak up campaign target? Pts and/or staff?
      - Need to define speak up campaign meaning
    - Do you have utilization data?
      - How do you know it is working?
    - How is organization acting on the patient feedback?
    - How are the moving from information to action?

- How was the program developed?
  - Created
  - Borrowed external source
- Do you know anyone else we should talk to (externally)?
- Steve to create spreadsheet hospital list for group
  - Contacts: Quality, safety, risk officers, chief experience officer
  - Maybe get from steering committee members
- Collect tools from institutions
- Evaluate tools., possibly modify tools them and determine which will be best use
  - Need to develop evaluation process
- Promote tools throughout WA
  - Set date
  - Create plan
- Facilities are suffering fatigue and it's difficult to do something that requires a lot of
  initiative and resources. It would be good to provide a tool that people can use as they
  wish and provide feedback on.
- Would like to look into patient activation down the line.
