We are pleased to invite interested speakers to submit proposals for presentations and posters at our 18th annual conference! We seek experienced, dynamic speakers who can present on their involvement with topics related to the conference theme for 2020 and engage effectively with our diverse set of attendees.

We welcome proposals from across the care spectrum and especially encourage those for interactive workshops and patients and patient advocates who wish to speak.

This annual event draws healthcare leaders from across the Northwest including:

- Safety, quality, and risk professionals from provider organizations and insurers
- Patients and family members who serve as care partners on advisory committees
- Physicians, nurses, and frontline clinicians from across the spectrum of care
- MHA, MPH and Health Profession Students
- Clinical program leaders
- Patient advocates
- State agencies

This year's theme is: DRIVING TOWARDS COLLABORATION AND SAFETY

With this theme we'd encourage presenters to think about:

Collaboration with patients and families: How can providers better engage patients and families as valued parts of the care team? **Collaboration within organizations and care teams**: What can organizations do to break down communication silos and encourage collaboration to strengthen care teams?

Collaboration within care transitions: How can patient's best be cared for with collaborative communication when being transferred between facilities or departments?

Collaboration with patient advocates: How can patient advocates be brought in as valuable collaborators, helping patients to advocate for themselves?

Potential Topic Tracks:

We encourage, but are not limited to, presentations that speak to the following:

On Ramps: Where have we been? In the midst of new changes, how can we maintain the origins of the patient safety movement and the best practices that came out of it? How can collaboration help us keep the momentum?

Milemarkers: Where are we now? What collaborative innovations are being made right now in your organization or practice and what shared learning can be gained from them?

Destinations: Where are we going, and how do we get there? What does collaboration look like in 2020 and beyond? What collaborative partnerships, ideas, and innovations are on the horizon?

SPEAKERS

- If the proposal is accepted, the speaker's registration fee is waived; an expense stipend may be available.
- Each speaker whose proposal is accepted will sign and return by February 1, 2020 a Letter of Agreement which specifies the timeline, responsibilities, and deliverables. If a speaker does not meet the conditions specified in the Letter, the conference organizers may rescind the invitation to speak.
- There are four formats for oral presentations:
 - 20 minute TedTalk Style "high intensity talk"
 - 60 minute session:
 - The 60 minutes are inclusive of presentation, discussion, and Q&A.
 - A request for more than one speaker must be justified in the presentation application for consideration by the planners.
 - We are also open to presentation structures that showcase real world application of patient safety concepts. Ideas include:
 - A guided debate
 - Facilitation of "<u>fishbowl</u>" <u>discussion</u> session.
 - Reenactment or live case study of patient safety case/concept
 - Two-hour workshop on a specific topic:
 - This session should be pragmatic and tool-based, providing the opportunity for attendees to learn how to implement an intervention or method.

POSTER PRESENTERS

- All posters must be in Styrofoam board, or able to rest free standing on an easel
- All posters must be free of commercial bias.
- Posters will be exhibited all day on the wall of a designated conference room. Authors are encouraged to be present with the poster before the plenary sessions and during breaks to discuss the project one-on-one with conference participants, and may provide handouts or printouts of the poster.
- Posters provide a visual display describing innovative approaches to practice, education, or research via short written narratives, tables, graphs, pictures, and/or charts. Maximum poster size is 36" x 48".
- A prize will be awarded for the best poster, selected by vote of the conference attendees.
